## X. **Committee Updates & Recommendations**

*Transportation Committee – Hugo Bruggeman, Chair, **Recommendation***

### **Recommendation 1:**

This recommendation is to "Pause our involvement in the City of Saint Paul's Stop for Me Campaign". Hugo provided background on the recommendation and how the campaign operates. POC means people of color.

Alexa shared the concern about the campaign was raised to all District Councils. Kensey stated there was a Live Facebook meeting held with the SPPD which was recorded discussing the campaign. She will share a link to this meeting.

There was significant discussion by Board members regarding the Stop for Me Campaign, including how the campaign/program could be modernized or re-imagined to include many of the items discussed by the Board.

**Revised Language:** The Macalester-Groveland Community Council recommends pausing involvement in the Stop for Me Campaign until the City of Saint Paul ensures it is implemented in an equitable manner that does not put people of color at risk.

Motion to adopt the recommendation made by Hugo Bruggeman and seconded by Tim Schmidt.

**Motion carries:** 16-0-1

**Recommendation 2:**

The recommendation is "Reducing Motor-Vehicle Traffic and Increasing Pedestrian and Bicyclist Access to Mississippi River Boulevard".

Hugo provided background about the recommendation. There was significant discussion among Board Members and meeting attendees.

1. 1st motion is to approve the recommendation made by Hugo Bruggeman and seconded by Tim Schmidt.
2. 2nd motion is to postpone the vote on the recommendation until a later time, made by Kathy McGuire. *Secretary's Note:* This motion was not seconded.

There was discussion about which motion should be voted on first. It was determined that we would vote on the 1st Motion to approve the resolution as written.

**Motion carries.** 16-1-2

**Post Meeting Secretary's Note:** On 9/11/2020 Tom Dietsche notified all Board Members via email that we should have voted on the 2nd motion first, to table or postpone the primary motion. As noted above, Motion #2 was not seconded during the meeting.
